Rock Creek Ranch Retreat Rules (RCRR)

The director or each camp is given these rules so that He/ she will insure that all camper know them before coming to camp. We realize that not everyone who comes to camp will agree with or understand the reason for some of our rules. We do expect, however, that all who use our camp will respect and abide by these rules. The director of the camp will be responsible for adherence to these rules so that the Ranch personnel will not become involved. RCRR reserves the right to refuse use of the camp to any person, group or family.

Behavior: in attitudes and actions, all campers should display respect for God and His creation, respect for others, and respect for themselves.

<u>Cabins:</u> cabins are to be used by the campers assigned to them. There is to be a counselor, in charge of and responsible for the cabin at all times. There is to be no mixing of the sexes in the cabins. No "Rough-housing" is allowed in the cabins. Posted rules for cleaning the facilities are to be followed. <u>No food, candy or drinks are permitted in the cabins per the forest service</u>.

Cleaning: campers are responsible for keeping the camp clean. The grounds are to be kept free of litter at all times. Campers are to clean up after themselves, leaving every area they use clean for the next use. Posted rules for cleaning the facilities are to be followed. This includes the kitchen, fellowship hall, chapel, cabins, and restrooms. At the end of each use, a walk-through inspection with the camp manager and camp director will be conducted.

<u>Damages:</u> upon arrival, anything found broken or out of order shall be reported to the camp manager. The group using the camp shall pay for any items damaged by the campers. At the end of each use, a walk-through inspection with the camp manager and camp director will be conducted.

<u>Drugs:</u> the use of alcohol, drugs or any type of substance abuse will not be permitted on the camp grounds or in the buildings. Violation of this police shall constitute a breach of agreement which may result in the termination of the camp with no refund.

Extinguisher: Fire extinguishers are to be used exclusively for fire safety. Call 911 immediately if any fire occurs. Complete written reports on all fires will be made to the Camp Manager. Unnecessary discharge is considered damage and the cost will be deducted from your deposit.

<u>Fires:</u> outside fires are only permitted in the campfire area and in the barbecue areas. Fires are to be kept small and safely contained. They are to be supervised at all times and thoroughly

extinguished with plenty of water and use a shovel to mix the water around to make sure it is completely out. (Outside fires may be prohibited during times of High Forest Fire Danger. Check with the Camp Manager before starting any fires. The barbecue is to be used for cooking purposes only.)

Food: the providing of food to any staff of RCRR is not expected nor should it be considered part of the fee for the camp use. Any invitation to eat by the camp director or Cook of any camp is a personal decision between those involved.

Furnishings and equipment: furniture of the camp shall not be moved without permission of the Camp Manager. If permission is given, all items shall be returned to their original place before leaving camp. Missing furniture and equipment is considered damage and the cost of replacing it will be deducted from the deposit.

Health and safety: all activities shall be conducted with an awareness of the camper's health and safety. All illnesses and injuries are to be reported promptly to the camp medical attendant. Call 911 immediately if there is an emergency or doubt about the well-being of a camper. A written report of Illnesses and / or injuries is to be given to the RCRR Manager.

Neighbors: Campers are not to trespass on neighboring property. After 10:00P.M. all activities must be kept indoors.

<u>Pest control</u>: Food and /or beverages are not permitted out of the dining hall(This includes candy). No food is to be thrown out to "feed the animals or birds." All food will be removed from the kitchen and campgrounds after each use. Food and beverage containers and wrappers are not to be dropped on the camp grounds.

Pets: the only pet allowed is the camp manager's dog.

Restrooms: Restrooms are to be properly used. They are to be left clean after each use. Do not throw bottles, cups, etc. down the toilets. Of anything is found (other than what is supposed to be there) an automatic \$200 will be added to your payment. Do not use the grounds as a restroom. If you find you need supplies, please let your camp director know and he/she will bring it to the attention of the camp manager.

Security: campers are not to leave the camp area without the knowledge and permission of the camp director. Counselors are to know where those under their charge are at all times.

<u>Tobacco:</u> smoking is not permitted in the cabins or on the campgrounds. The only designated area for smoking is at the camp fire site. This is the only area to be used for smoking. Under fire hazard restrictions smoking will be allowed anywhere on the camp grounds. This will be strictly enforced.

Trails: prevent damage caused by erosion and soil compaction by keeping on the trails.
